

Hard Times for Our Kids

KidCare is in trouble. Payroll contributions are down, but the requests to help needy students are way up. Lisa Levee, the TABCO administrative assistant who handles the fund, tells us,

"As of today, the fund has disbursed more than it did the entire year for 2013."

Last November (2013), \$10,200 had been disbursed to aid 255 students, and the total for the entire 2013-2014 year was

\$12, 240, distributed to 306 students. Compare that to this year's figures-KidCare grants of \$12, 720 have been distributed to aid 318 students just in the first quarter.

We know that many of our students are homeless; in fact, Lisa estimates that seven out of ten of the requests for KidCare aid coming in this year are to help homeless kids who are without the necessary items to make school attendance possible--as basic as shoes and clothing.

Unfortunately, without an increase in contributions, the capacity to continue helping our needy kids will be depleted. In 2011, there were 215 employees donating

to KidCare via payroll deductions --that figure is down to 170 employees this year. Baltimore County employs about 8,200 teachers, so about 2% of us give via payroll deduction. KidCare receives some monies through fund-raising activities, most notably the KidCare Raffle held each year at the annual Retirement and Recognition Dinner, which raised \$3658 last May, and

some donations are made by several of our endorsed vendors. However, without the sustaining funds coming in through payroll deductions, our teacher-created and supported charity cannot continue to fulfill the mission of helping our most needy students.

Health Care Rate Splits

As part of the five-year health care agreement we ratified two years ago, the rate split percentages are changing as of January 1, 2015. The Cigna OAP (in/ out of network) is going from 15% to 17% paid by the employee (83% paid by BCPS). The Kaiser HMO and the Cigna OAPIN plans are going from 12% to 13% paid by the employee (87% paid by BCPS).

Employees hired on or after January 1, 2013 automatically go to the end point of the five-year phase-in period which is 20% for the Cigna OAP plan and 15% for either the Kaiser or Cigna OAPIN plans. There are still two more years after this one before we have reached the final percentages for the health care rate split changes, i.e., 2017. Each year you have seen an incremental increase instead of having to deal with it in one big jump. That is why we negotiated it incrementally. Remember, the health care benefit calculator is based on the calendar year from January through December.
