Discounts and benefits for TABCO-R/MSEA-R/NEA-R members

If you haven't visited the NEA member benefits website lately (or ever), there are even more discounts available to you as a retired member. To access these, enter **neamb.com** in your search engine. When you reach the website, set up an account if you haven't used it previously, or enter your email address and password. Examples of discounts that you may want to try include:

-Movie tickets (\$40.95 for a four pack of tickets for AMC theaters, valued at \$64.00-they do not expire), Broadway show tickets, and tickets for theme parks.

-Using the NEA Discount Marketplace, a Rakuten cashback shopping account can be set up, providing quarterly cash refunds based on online shopping (watch the short explanatory video).

-Travel discounts (as a test, the price on a night at a hotel in Portsmouth, NH was \$117, including tax and fees vs. \$139 on Booking.com). Other travel discounts are available for car rental, flights, etc.

There are many services and insurances offered. For example, a member can add guaranteed issue life insurance of \$3000 for \$12.50 per month, or \$6000 for \$25.00 per month.

Steering Committee member Ed Kitlowski suggested that hearing from some of our members about their motivations for joining TABCO-Retired might be interesting for those who are newly retired, or just haven't looked into retiree membership yet. He begins with his own story.

ED KITLOWSKI:

I retired from BCPS in 2016. On the last day of school, I got in my car and sat, as this would be the last time I left the school parking lot. It was the closing of 33 years of teaching. I imagine many people who teach share my experience that being a teacher was more than just an occupation--who I am is "teacher." Being a teacher manifested itself in many ways. For my summer jobs, I taught foreign students for several years and felt more enlivened. I taught in Poland one summer. I also taught at Howard Community College in a program called Project Access during the summer. So that day in June 2016 in the parking lot was significant.

I believe most people become teachers to make a difference. I always felt it was a privilege to be a part of so many people's lives. Being a teacher meant living a full life of emotions, sharing a life of triumphs and heartbreaks with thousands of people. I was going to miss that.

When I heard there was a group of retired BCPS teachers calling themselves TABCO-Retired, I contacted them. I had been a TABCO representative most of my career. There is a philosophic idea that underneath every complaint is a commitment to excellence. I was very committed to public education

sized its importance repeatedly to BCPS. The Cigna statement is reassuring, but we will be inquiring about the school system's plans for the coming year, and continuing to advocate for having our choices of preferred plans.

DEFINING OUR MISSION

As a member of the TABCO Board of Directors. I have been working with others on updating the TABCO Policy Manual, which is a sister document to TABCO's bylaws. The policy manual defines in detail the policies and procedures of TABCO's operations. On May 2, the board of directors passed the updated language for TABCO-Retired.

With additional and more defined language, the retiree organization has strengthened our rights as members affiliated with TABCO and expanded our roles connected to the active organization. There are now clear guidelines. Among the important items are:

~Acting as an advocate for responding to retirees' concerns regarding rights and delayed compensation benefits guaranteed through their previous employment in BCPS."

~A sub-committee shall be created to carry out KidCare fundraising initiatives and basket raffle preparation.

~Retirement and financial planning workshops: The committee shall plan and coordinate retirement workshops with appropriate vendors.

~As a class of membership provided for in the TABCO Bylaws and by affiliation with MSEA and NEA. retired members shall be entitled to certain rights, such as attendance at TABCO activities as appropriate, and access to member benefits and discounts.

~TABCO-Retired member of the TABCO Board of Directors: To be eligible to run for the position of retired member of the Board of Directors, a person must have been a member of NEA-R, MSEA-R and TABCO-Retired for at least the three years preceding the election and be capable of attending board meetings, committee meetings, and other board events in person on a routine basis.

These additions to the policy manual (the new language is in red) work to solidify retired membership as both actual and valuable connections with TABCO. We owe a debt of gratitude to both TABCO Secretary Seth Rich, who has been the leader in the manual revision efforts, and for continued support from President Cindy Sexton. And the board of directors, as well, for confirming the updates.

Celebrating 40+ Years of Helping Kids

KidCare was approved at the representative assembly in 1980 and incorporated in 1981 as a fund to assist needy students enrolled in Baltimore County Public Schools. One hundred percent of the money donated goes to students and their families for needed items such as clothes, shoes, book bags, school supplies and coats. TABCO donates the administrative time to manage the funds.

In addition to individual fund drives such as the one at the annual Retirement & Recognition Dinner, KidCare relies mainly on payroll deduction from BCPS employees and donations from others. BCPS students need this assistance, and they need your help. Since its inception, KidCare has helped an estimated 13,738 students and given out an estimated \$711,000 to needy students. There is never a shortage of requests for assistance, and we don't want to turn down our most needy students.

So far this school year (2024-2025), \$21,440 has been spent to help 429 students. Last year (2023-2024), a total of \$48,585 in vouchers helped
